Broadband Advisory Committee Minutes 2/13/2020

Attendees:

Allen Boaz called the meeting to order and welcomed everyone. Two Bedford residents joined us.

1. Old Business

Allen Boaz contacted Bob Davis (District 6, BOS) and BRWA. After talking with Brian Key from BRWA, it was decided to hold a meeting on 2/21 at BRWA to discuss contract issues and frequencies to ensure there is no interference with B2X. Those attending will be Allen Boaz, Brian Key, George Condyles, Anthony Smith, Sean Cai, Edgar Tuck, Amanda Kaufman and Jordan Mitchell.

VATI/TRCC Grants – George Condyles reminded everyone that the County has received more than \$1.5M in grants from VATI and the Tobacco Commission. There is a new round of deadlines coming up for VATI grants and Traci Blido spoke about two subdivisions on behalf of Shentel that were delayed in the last round. There's a DHCD info session coming up in April that Traci and Amanda may attend, but new VATI grant funds won't be available until 2021 if we apply in 2020. https://dhcd.virginia.gov/index.php/vati

2. New Broadband Providers to Bedford (Wire and Wireless)
No discussion.

3. Project Status Report – Through February 7, 2020 (Milestone and Budget Trackers Attached)

Anthony Smith shared the status on all towers. Please also look at the milestone tracker for more detail, which is attached to these minutes:

Big Island

- Still waiting to stack the tower at the site (weather being the issue). Will need to wait for the site to dry out, but hope to stack the tower before the end of the month (possibly next Friday, Feb. 21, 2020).

- VDOT approved fiber run to site, will start the run from Big Island Elementary to the site before the end of the month (February 2020).

Big Island Elementary

- 100% complete, fiber installed and compound ready. Waiting for town electric company for power to the site, which is estimated to be 2 weeks down the road (February 27, 2020).

Montvale

- 100% complete. Waiting for SCS to move equipment down on the tower, per agreement. Equipment for this site is ready to be installed.

Hardy Collection

- Tower to be stacked Saturday if weather permits (February 15, 2020).

Shady Grove

 Tower on-site. Attempted to stack Monday, February 10, 2020, but weather would not permit. Scheduled to stack tomorrow (February 14, 2020), but ground is probably going to be too wet so it may push to Saturday (February 15, 2020).
 Grounding and fencing to come after stacking.

McGhee Road

- BRWA deadline to move mobile unit and other equipment is February 17, 2020. This will need to be removed piece by piece (ongoing).

<u>Boonsboro</u>

 Issues due to school buses. Want to go out next Saturday (February 22, 2020) to get light pole down and work on the fiber at the site, which is a quarter mile run.
 Looking to stack on Easter break (mid-April 2020), and will continue to work with the school.

Moneta

- Planning Commission hearing on SRP is scheduled for February 18, 2020. Will need to amend the SHPO due to site change and order new geotech.
- April 2020 stack date for the tower is anticipated.

Huddleston

- Tower is stacked, waiting on the site to dry out for grounding and fencing.

New London

- Fiber route is laid out.
- BRT is continuing discussion with the BRWA to determine the specifics of the leasing of the co-location.
- George Condyles provided a handout related to broadband and an email correspondence with FCC.

- Anthony Smith says that in order to keep in line with the grants they have to be able to provide internet in New London so they won't be able to sign any lease that would keep them from providing internet.

Wheat Valley

- Sean Cai stated that the BRWA is requiring a survey in order to sign a lease.
- Jordan Mitchell requested information from Sean Cai related to the setback of the tower at the site so he can start the administrative variance process for a reduced setback today (February 13, 2020).

Landfill

- Broke ground, will need to dry out to stack the tower.

3.b. Other Business not on Agenda

BRT clarified that BRISCnet is the company name: Blue Ridge Internet Service Company.

Anthony Smith is awaiting a County decision regarding a draft contract to provide BRT compensation for securing co-locators on towers.

BRT confirmed there are no anticipated issues with fiber runs (using VDOT and power poles with electric providers). They are tying into Mid-Atlantic fiber points. The runs have been planned a long time ago and analyzed.

Status of SCS moving down on the Montvale tower. SCS is waiting for the contract between the County and SCS to be completed before beginning work on the Montvale tower. Robert Hiss and Patrick Skelley are working on the lease and plan to have this done by end of next week (February 21, 2020). SCS has requested that frequencies be part of the lease. George suggested to BRT that a Memorandum of Understanding (MOU) between BRT and SCS be put into place to address the frequencies. SCS will be installing new LTE equipment, which should improve service to customers.
