#### **RECOMMENDATION**

Staff recommends supporting this project.

#### SUMMARY

The Forest Rotary and Forest Kiwanis have shown interest in providing funds to construct new amenities at the Forest Park. Forest Park is located behind the Forest Library and adjacent to the Forest Recreation Center. The specific amenities that have been discussed are play structures and a possible covered pavilion. The Forest Library has also shown interest and support for the project, specifically as it relates to a cover pavilion for outdoor reading activities. If the Board is supportive of this project, staff would like to work with these service clubs to develop a survey to gain public input from Forest Library users about what types of park amenities they would like to see at the site. Once a plan has been developed, using this public input, and the service clubs have completed their capital campaigns, the proposed plan for the site will be presented to the Board.

There is \$45,000 budgeted in the current fiscal year's CIP to install a paved walking path to connect the Forest Park with the Forest Recreation Center. Virginia A&E is currently underway with the design work for the project. The A&E work is estimated to cost \$7,500. Once this is complete, the construction can be bid out with remaining funds (\$37,500). This construction is anticipated to start in late summer/early fall. This project will allow for better use, access to additional parking, and accessibility between the properties. This project will be constructed concurrent to the park amenity project outlined in this memo.

#### RECOMMENDATION

Staff recommends installing a vegetation buffer.

#### **SUMMARY**

Independence Park is in need of a privacy buffer between the park and adjacent private properties. 1,300 linear feet of buffer will be required for this project. A map showing where the buffer needs to be installed is attached to this memo.

Staff solicited multiple quotes for both fencing and vegetation from New Leaf Farms, Lynchburg Fence and Railing, and Central Virginia Fencing.

From the quotes received, a wooden privacy fence ranged from \$44,100 to \$54,800 and a vegetation buffer ranged from \$1,950 to \$2,040. Pricing may be dependent on season and availability. Due to cost, staff recommends a vegetation buffer, which would consist of approximately 30 cypress trees that are each a minimum of five feet tall.

#### FISCAL IMPACT

No fiscal impact at this time. If the Board would like to move forward with a permanent buffer, there will need to be new funds budgeted for this project. If the Board approves this project, staff recommends funding it through the reappropriation process in September.





#### RECOMMENDATION

Authorize the lease renewal and approve the resolution.

#### SUMMARY

Currently, the Southern Virginia Internet Crimes Against Children Task Force is occupying 11,000 square feet of office space in the Forest, Virginia area that it has been leasing since 2010. The property owner has provided lease rates at or below market averages per square foot for this space. The current lease expires in September 2021. This renewal is for 5 years and locks in rates that will continue to be under current market rate averages. The agreed upon rate ending in 2026 is less than current 2021 market rates in the Forest, Virginia area.

Current 2021 advertised rates per square foot for an 11,500 square foot retail space in Forest, Virginia average \$17.00 per square foot. The agreed upon monthly rate for the proposed lease renewals starting October 1, 2021 is \$10,385.83, or approximately \$11.33 per square foot. The agreed upon rate will increase 3.0% each year, commencing on October 1. As such, the agreed upon monthly rate for the final year of the lease, effective October 1, 2025, is \$11,689.34, or approximately \$12.75 per square foot.

#### FISCAL IMPACT

No fiscal impact. The total cost of the proposed lease renewal, as well as any additional utility costs, are covered by state and/or federal grants with no local match requirements.

#### PRIOR ACTIONS

This lease has been renewed/modified seven (7) times since the original lease agreement date of May 5, 2010.



#### RECOMMENDATION

Acceptance of grant funds and approval of resolution

#### **SUMMARY**

The Virginia Department of Criminal Justice Services (DCJS) has awarded Bedford County an Internet Crimes Against Children award in the amount of \$1,450,000. These funds are contingent on fees collected by DCJS. The original award period was July 1, 2020 through June 30, 2021; however, an extension was granted by Department of Criminal Justice Services through August 15, 2021 due to funds being released late. ICAC will receive \$826,960.33 at the signing of the FY21 Memorandum of Understanding (MOU) documents with another undisclosed amount to be received before August 15, 2021. These funds are available until they are fully expended and the award does not require a local match.

Funding will be used to provide supplies, utilities, software, telecommunications, internet service, and the salaries and benefits of 15 full-time staff positions. Staff recommends Board acceptance of this award, as well as a Supplemental Appropriation of \$1,450,000 for FY 2020-2021 for the additional state funds for the Internet Crimes Against Children program. A reappropriation of unexpended funds available as of June 30, 2021 will be requested as part of a separate resolution related to grant reappropriations.

#### FISCAL IMPACT

FY21 supplemental appropriation of \$1,450,000 to the Grant Fund with no local match requirement.

#### ACCEPTING THE STATE INTERNET CRIMES AGAINST CHILDREN PROGRAM AWARD

**WHEREAS**, the Bedford County Sheriff's Office has been the lead agency of the Southern Virginia Internet Crimes Against Children Task Force since 1998; and

**WHEREAS**, the Southern Virginia Internet Crimes Against Children Task Force is part of the federal ICAC Task Force program administered through the Office of Juvenile Justice and Delinquency Prevention, and receives federal funds to support its mission; and

**WHEREAS**, the Southern Virginia Internet Crimes Against Children Task Force also receives state funding, as authorized under COV 17.1-275.12; and

WHEREAS, this funding comes in two blocks, one to support the main headquarters of the Southern Virginia Internet Crimes Against Children Task Force, and one to support the affiliate members of the task force; and

**WHEREAS**, funds made available to the Southern Virginia Internet Crimes Against Children Task Force for its main headquarters was set at \$1,450,000 for the period of July 1, 2020 through June 30, 2021, with an extension through August 15, 2021; and

**WHEREAS**, this extension was granted due to the challenges of receiving FY 2020-2021 funding, due to COVID-19; and.

WHEREAS, this funding does not require a local match by Bedford County.

**Now, Therefore, Be It Resolved,** by the Bedford County Board of Supervisors, that the Board does hereby accept FY21 state grant funding of up to \$1,450,000 for continued operation of the Southern Virginia Internet Crimes Against Children Task Force.

**BE IT FURTHER RESOLVED,** that the Board authorizes a FY 2020-2021 supplemental appropriation to the grant fund for the funds awarded.

DCJS Memorandum of Understanding #: FY21-003

#### PURPOSE

The purpose of this document is to establish a memorandum of understanding (MOU) between the Bedford County Sheriff's Office — Southern Virginia Internet Crimes Against Children (SOVA-ICAC) Task Force and the Virginia Department of Criminal Justice Services (DCJS). The primary purpose of the SOVA-ICAC Task Force shall be to investigate, prosecute, and deter the possession, production, and distribution of child pornography and the utilization of the Internet to seek children as sexual victims. This MOU defines the responsibilities of both the SOVA-ICAC Task Force and DCJS as it pertains to the continued work in support of ICAC-related work, combating and prosecuting Internet crimes against children.

#### 2. GENERALLY:

- 2.1 The Memorandum of Understanding (MOU) is effective upon the signature of an authorized representative of the Bedford County Sheriff's Office Southern Virginia Internet Crimes Against Children Task Force and the Director of DCJS.
- 2.2 This MOU shall remain in full force and effect until August 15, 2021.
- 2.3 Amendments to this MOU must be agreed upon by both agencies in writing, and amendments shall remain in force until both agencies confirm in writing they are no longer necessary or desirable.

#### 3. AVAILABILITY OF FUNDS AND APPROPRIATIONS:

3.1 It is understood and agreed between the parties that they shall be bound hereunder only to the extent of funds available or which may become available and that this MOU is subject not only to the state appropriation for the ICAC Fund, but also to the amount collected and deposited into the ICAC Fund.

#### 4. SCOPE OF WORK:

- 4.1 The SOVA-ICAC Task Force and DCJS agrees that DCJS will:
  - 4.1.1 Make a payment to the SOVA-ICAC Task Force of \$826,960.33 upon the signature of authorized representatives from both parties. This represents the remaining cash on hand collected for Fiscal Year 2021.

- 4.1.2 DCJS will also make a payment on or before August 15, 2021, for ICAC funds received by DCJS for June activity.
- 4.2 The SOVA-ICAC Task Force and DCJS agrees that the SOVA-ICAC Task Force will:
  - 4.2.1 Conduct ICAC-related activities as deemed appropriate and in accordance with State budgetary language. All expenditures related to the ICAC Fund shall be utilized in a manner to support activities consistent with budgetary language. Detailed justification of the expenditures and activities shall be provided within the annual report to the General Assembly.
  - 4.2.2 Submit to DCJS the SOVA-ICAC Task Force annual legislative expenditure report outlining how the ICAC funds were utilized, via Nicole Phelps (nicole.phelps@dcjs.virginia.gov) and/or other designated DCJS representatives.
  - 4.2.3 Maintain documentation, including, but not limited to, original procurement and employment documentation, for tracking and reporting purposes and make such documentation available to DCJS upon request.

This appropriation includes an estimated \$4,800,000 the first year and an estimated \$4,800,000 the second year from federal funds pursuant to the Omnibus Crime Control Act of 1968, as amended. Of these amounts, ten percent is available for administration, and the remainder is available for grants to state agencies and local units of government. The remaining federal funds are to be passed through as grants to localities, with a required 25 percent local match. Also included in this appropriation is \$452,128 the first year and \$452,128 the second year from the general fund for the required matching funds for state agencies.
- 2. The Department of Criminal Justice Services shall provide a summary report on federal anti-crime and related grants which will require state general funds for matching purposes during FY 2013 and beyond. The report shall include a list of each grant and grantee, the purpose of the grant, and the amount of federal and state funds recommended, organized by topical area and fiscal period. The report shall indicate whether each grant represents a new program or a renewal of an existing grant. Copies of this report shall be provided to the Chairmen of the Senate Finance and House Appropriations Committees and the Director, Department of Planning and Budget by January 1 of each year.
- B. The Department of Criminal Justice Services is authorized to make grants and provide technical assistance out of this appropriation to state agencies, local governments, regional, and nonprofit organizations for the establishment and operation of programs for the following purposes and up to the amounts specified:
- 1.a. Regional training academies for criminal justice training, \$1,001,074 the first year and \$1,001,074 the second year from the general fund and an estimated \$1,649,315 the first year and an estimated \$1,649,315 the second year from nongeneral funds. The Criminal Justice Services Board shall adopt such rules as may reasonably be required for the distribution of funds

and for the establishment, operation and service boundaries of state-supported regional criminal justice training academies.

- b. The Board of Criminal Justice Services, consistent with § 9.1-102, Code of Virginia, and § 6VAC-20-20-61 of the Administrative Code, shall not approve or provide funding for the establishment of any new criminal justice training academy from July 1, 2020, through June 30, 2022.
- c. Notwithstanding subsection B.1.b. of this item, the Board of Criminal Justice Services may approve a new regional criminal justice academy serving the Counties of Clarke, Frederick, and Warren; the City of Winchester; the Towns of Berryville, Front Royal, Middletown, Stephens City and Strasburg; the Northwestern Adult Detention Center; and, the Frederick County Emergency Communications Center, to be established and operated consistent with a written agreement, provided to the Board, between the local governing bodies, chief executive officers, and chief law enforcement officers of the aforementioned localities, and the Rappahannock Regional Criminal Justice Academy. The new academy shall be eligible to receive state funding in a manner consistent with the currently existing regional criminal justice training academies. However, no current existing regional criminal justice training academy other than the Rappahannock Regional Criminal Justice Academy will receive less funding as a result of the creation of the new regional academy.
- 2. Virginia Crime Victim-Witness Fund, \$5,692,738 the first year and \$5,692,738 the second year from dedicated special revenue, and \$943,700 the first year and \$943,700 the second year from the general fund. The Department of Criminal Justice Services shall provide a report on the current and projected status of federal, state and local funding for victim-witness programs supported by the Fund. Copies of the report shall be provided annually to the Secretary of Public Safety and Homeland Security, the Department of Planning and Budget, and the Chairmen of the Senate Finance and House Appropriations Committees by October 16 of each year.
- 3.a. Court Appointed Special Advocate (CASA) programs, \$1,615,000 the first year and \$1,615,000 the second year from the general fund.
- b. In the event that the federal government reduces or removes support for the CASA programs, the Governor is authorized to provide offsetting funding for those impacted programs out of the unappropriated balances in this Act.
- 4. Domestic Violence Fund, \$3,000,000 the first year and \$3,000,000 the second year from the dedicated special revenue fund to provide grants to local programs and prosecutors that provide services to victims of domestic violence.
- 5. Pre and Post-Incarceration Services (PAPIS), \$3,286,144 \$2,786,144 the first year and \$3,286,144 the second year from general fund to support pre and post incarceration professional services and guidance that increase the opportunity for, and the likelihood of, successful reintegration into the community by adult offenders upon release from prisons and jails.
- 6. To the Department of Behavioral Health and Developmental Services for the following activities and programs: (i) a partnership program between a local community services board and the district probation and parole office for a jail diversion program; (ii) forensic discharge planners; (iii) advanced training on veterans' issues to local crisis intervention teams; and (iv) cross systems mapping targeting juvenile justice and behavioral health.
- 7. To the Department of Corrections for the following activities and programs: (i) community residential re-entry programs for female offenders; (ii) establishment of a pilot day reporting center; and (iii) establishment of a pilot program whereby non-violent state offenders would be housed in a local or regional jail, rather than a prison or other state correctional facility, with rehabilitative services provided by the jail.
- 8. To Drive to Work, \$75,000 the first year and \$75,000 the second year from the general fund and \$75,000 the first year and \$75,000 the second year from such federal funds as may be available to provide assistance to low income and previously incarcerated persons to restore their driving privileges so they can drive to work and keep a job.
- 9. For model addiction recovery programs administered in local or regional jails, \$153,600 the first year and \$153,600 the second year from the general fund. The Department of Criminal Justice Services, consistent with the provisions of Chapter 758, 2017 Acts of Assembly, shall award grants not to exceed \$38,400 to four pilot programs selected in consultation with the Department of Behavioral Health and Developmental Services.

- C.1. Out of this appropriation, \$27,690,378 \$26,540,378 the first year and \$27,690,378 the second year from the general fund is authorized to make discretionary grants and to provide technical assistance to cities, counties or combinations thereof to develop, implement, operate and evaluate programs, services and facilities established pursuant to the Comprehensive Community Corrections Act for Local-Responsible Offenders (§§ 9.1-173 through 9.1-183 Code of Virginia) and the Pretrial Services Act (§§ 19.2-152.2 through 19.2-152.7, Code of Virginia). Out of these amounts, the Director, Department of Criminal Justice Services, is authorized to expend no more than five percent per year for state administration of these programs.
- 2. The Department of Criminal Justice Services, in conjunction with the Office of the Executive Secretary of the Supreme Court and the Virginia Criminal Sentencing Commission, shall conduct information and training sessions for judges and other judicial officials on the programs, services and facilities available through the Pretrial Services Act and the Comprehensive Community Corrections Act for Local-Responsible Offenders.
- D.1. Out of this appropriation, \$225,000 the first year and \$225,000 the second year from the general fund is provided for Comprehensive Community Corrections and Pretrial Services Programs for localities that belong to the Central Virginia Regional Jail Authority. These amounts are seventy-five percent of the costs projected in the community-based corrections plan submitted by the Authority. The localities shall provide the remaining twenty-five percent as a condition of receiving these funds.
- 2. Out of this appropriation, \$600,000 the first year and \$600,000 the second year from the general fund is provided for Comprehensive Community Corrections and Pretrial Services Programs for localities that belong to the Southwest Virginia Regional Jail Authority. These amounts are seventy-five percent of the costs projected in the community-based corrections plan submitted by the Authority. The localities shall provide the remaining twenty-five percent as a condition of receiving these funds.
- E. In the event the federal government should make available additional funds pursuant to the Violence Against Women Act, the department shall set aside 33 percent of such funds for competitive grants to programs providing services to domestic violence and sexual assault victims.
- F.1. Out of this appropriation, \$4,700,000 the first year and \$4,700,000 the second year from the general fund and \$1,710,000 the first year and \$1,710,000 the second year from such federal funds as are available shall be deposited to the School Resource Officer Incentive Grants Fund established pursuant to § 9.1-110, Code of Virginia.
- 2.a. The Director, Department of Criminal Justice Services, is authorized to expend \$410,877 the first year and \$410,877 the second year from the School Resource Officer Incentive Grants Fund to operate the Virginia Center for School Safety, pursuant to § 9.1-110, Code of Virginia.
- b. The Center for School Safety shall provide a grant of \$100,000 in the first year and \$100,000 in the second year to the York County-Poquoson Sheriff's Office for the statewide administration of the Drug Abuse Resistance Education (DARE) program.
- 3. Subject to the development of criteria for the distribution of grants from the fund, including procedures for the application process and the determination of the actual amount of any grant issued by the department, the department shall award grants to either local law-enforcement agencies, where such local law-enforcement agencies and local school boards have established a collaborative agreement for the employment of school resource officers, as such positions are defined in § 9.1-101, Code of Virginia, for the employment of school resource officers, or to local school divisions for the employment of school security officers, as such positions are defined in § 9.1-101, Code of Virginia, for the employment of school security officers in any public school. The application process shall provide for the selection of either school resource officers, school security officers, or both by localities. The department shall give priority to localities requesting school resource officers, school security officers, or both where no such personnel are currently in place. Localities shall match these funds based on the composite index of local ability-to-pay.
- 4. Included in this appropriation is \$202,300 the first year and \$202,300 the second year from the general fund for the implementation of a model critical incident response training program for public school personnel and others providing services to public schools, and the maintenance of a model policy for the establishment of threat assessment teams for each public school, including procedures for the assessment of and intervention with students whose behavior poses a threat to the safety of public school staff or other students.

- 5. Included in the amounts appropriated for this item is \$132,254 the first year and \$132,254 the second year from the general fund for the purposes of collection and analysis of data related to school resource officers, pursuant to House Bill 271 of the 2020 Session of the General Assembly.
- G. Included in the amounts appropriated in this Item is \$2,500,000 the first year and \$2,500,000 the second year from the general fund for grants to local sexual assault crisis centers (SACCs) and domestic violence programs to provide core and comprehensive services to victims of sexual and domestic violence, including ensuring such services are available and accessible to victims of sexual assault and dating violence committed against college students on- and off-campus.
- H.1. Out of the amounts appropriated for this Item, \$2,658,420 the first year and \$2,658,420 the second year from nongeneral funds is provided, to be distributed as follows: for the Southern Virginia Internet Crimes Against Children Task Force, \$1,450,000 the first year and \$1,450,000 the second year; and, for the creation of a grant program to law enforcement agencies for the prevention of internet crimes against children, \$1,208,420 the first year and \$1,208,420 the second year.
- 2. The Southern Virginia and Northern Virginia Internet Crimes Against Children Task Forces shall each provide an annual report, in a format specified by the Department of Criminal Justice Services, on their actual expenditures and performance results. Copies of these reports shall be provided to the Secretary of Public Safety and Homeland Security, the Chairmen of the Senate Finance and House Appropriations Committees, and Director, Department of Planning and Budget prior to the distribution of these funds each year.
- 3. Subject to compliance with the reports and distribution thereof as required in paragraph 2 above, the Governor shall allocate all additional funding, not to exceed actual collections, for the prevention of Internet Crimes Against Children, pursuant to § 17.1-275.12, Code of Virginia.
- I. Out of the amounts appropriated for this item, \$50,000 the first year and \$50,000 the second year from the general fund is provided for training to local law enforcement to aid in their identifying and interacting with individuals suffering from Alzheimer's and/or dementia.
- J.1. Included in the appropriation for this item is \$2,500,000 the first year and \$2,500,000 the second year from the general fund to continue the pilot programs authorized in Item 398, Chapter 836, 2017 Acts of Assembly. The number of pilot sites shall not be expanded beyond those participating in the pilot program the first year.
- 2. The funding provided to each pilot site shall supplement, not supplant, existing local spending on these services. Distribution of grant amounts shall be made quarterly pursuant to the conditions of paragraph J.3. of this item.
- 3. The Department shall collect on a quarterly basis qualitative and quantitative data of pilot site performance, to include: (i) mental health screenings and assessments provided to inmates, (ii) mental health treatment plans and services provided to inmates, (iii) jail safety incidents involving inmates and jail staff, (iv) the provision of appropriate services after release, (v) the number of inmates re-arrested or re-incarcerated within 90 days after release following a positive identification for mental health disorders in jail or the receipt of mental health treatment within the facility. The Department shall provide a report on its findings to the Chairmen of the House Appropriations and Senate Finance Committees no later than October 15th each year.
- 4. The department is authorized to expend up to \$125,000 per year out of the amounts allocated in Paragraph J.1. of this item for costs related to the administration of the jail mental health pilot program.
- K. Included in the appropriations for this Item is \$300,000 the first year and \$300,000 the second year from the general fund for the Department of Criminal Justice Services to make competitive grants to nonprofit organizations to support services for law enforcement, including post critical incident seminars and peer-supported critical incident stress management programs to promote officer safety and wellness, under guidelines to be established by the Department. The Department shall evaluate the effectiveness of the program and report on its findings to the Secretary of Public Safety and Homeland Security, the Director of the Department of Planning and Budget, and the Chairmen of the House Appropriations and Senate Finance Committees by July 1, 2022.

L. Included in the appropriation for this item is \$916,066 in the first year and \$916,066 in the second year from the general fund for the Virginia Beach Correctional Center for the Jail and Re-entry Service Coordination Pathway, which is a joint operation between the Virginia Beach Department of Human Services and the Virginia Beach Sheriff's Office. The program consists of diversion, screening, assessment, treatment, and re-entry services for all incarcerated individuals with an active mental illness or substance use disorder diagnosis.

M. Included in this appropriation for this item, \$2,645,244 the first year and \$193,658 the second year from the general fund and two positions for the Department of Criminal Justice Services to make competitive grants to five localities to support evidence-based gun violence intervention and prevention initiatives. The Department shall evaluate the implementation and effectiveness of the programs in each locality that received the award, and provide a report that details the amount awarded, its findings and recommendations to the Governor, Secretary of Public Safety and Homeland Security, Director of the Department of Planning and Budget, and the Chairmen of the House Appropriations and the Senate Finance Committees by November 1, 2021. The funding provided to each locality shall supplement, not supplant, existing local spending on these services.

N. Out of the appropriation in this item, \$1,500,000 the first year and \$1,500,000 the second year from the general fund is allocated for the Department of Criminal Justices Services to make competitive grants to localities to combat hate crimes, including but not limited to target hardening activities, contractual security services, critical technology infrastructure, cybersecurity resilience activates, monitoring, inspection and screening systems; security-related training for employed or volunteer security staff; and terrorism awareness training for employees. The funds appropriated in this item shall be distributed to localities that have established a partnership program with institutions or nonprofit organizations that have been targets of or are at risk of being targeted for hate crimes. The Department shall establish grant guidelines to implement these provisions and shall provide a biennial or annual request for funding from localities, based on the guidelines. For each grant requested, the application shall document the need for the grant, goals, and budget expenditure of these funds and any other sources that may be committed by localities, institutions or nonprofit organizations. Funding provided in this item shall not be used to supplant the funding provided by localities to combat hate crimes.

O.1. The Department of Criminal Justice Services shall review the feasibility and costs to the Commonwealth and localities for the implementation of a pilot program, operated in partnership with one or more participating localities identified by the department, to assess the operation of a uniform reporting mechanism for appropriate criminal justice agencies, as identified in § 9.1-101, Code of Virginia, to collect data relating to bail determinations made by judicial officers conducting hearings pursuant to § 19.2-80, § 19.2-120, or § 19.2-124 of the Code of Virginia, in order to facilitate the purpose of Article 1 (§ 19.2-119 et seq.) of Chapter 9 of Title 19.2 of the Code of Virginia.

2. As part of its review, the department shall identify the methods, feasibility and costs associated with collecting, at minimum, the following information from localities participating in the pilot program: (i) the hearing date of any hearing conducted pursuant to § 19.2-80, § 19.2-120, or § 19.2-124 of the Code of Virginia and the date any individual is admitted to bail; (ii) information about the individual, including the individual's year of birth, race, ethnicity, gender, primary language, and residential zip code; (iii) the determination of the individual's indigency pursuant to § 19.2-159 of the Code of Virginia; (iv) information related to the individual's charges, including the number of charges; the most serious offense the individual is charged with; the code section for such offense; the general description of such offense; whether such offense is a felony; misdemeanor, civil infraction, or other type of offense; and the specific classification of any felony or misdemeanor offense; (v) if the individual is admitted to bail, information related to the conditions of bail and the bond, including whether the bond was secured or unsecured; all monetary amounts set on the bond, including amounts set on both secured and unsecured bonds; any initial nonmonetary conditions of release imposed; any subsequent modifications; and whether the individual utilized the services of a bail bondsman; (vi) if the individual is not admitted to bail, the reason for the denial; (vii) any outstanding arrest warrants or other bars to release from any other jurisdiction; (viii) any revocation of bail due to a violation of such individual's conditions of release, failure to appear for a court hearing, or the commission of a new offense by such individual; (ix) the date the individual is sentenced to an active term of incarceration and the date such individual begins serving such active term; (x) all dates the individual is released or discharged from custody, including release upon satisfaction of the terms of any recognizance, release upon the disposition of any charges, or release upon completion of any active sentence; (xi) the reason for any release or discharge from custody, including whether the individual posted a bond, was released on a recognizance; or was released under terms of supervision, or whether there was a disposition of the charges that resulted in release of the individual. If the reason for release is due to a court order or a disposition of the charges resulting in release, the data collected shall include the specific reason for release, including the nature of the court order or, if there was a conviction, the particular sentence imposed. The data shall also include a list of definitions of any terms used by the locality

to indicate reasons for release or discharge; and (xii) the average cost for housing the individual in the local correctional facility, as defined in § 53.1-1, Code of Virginia, for one night. Collected data shall be disaggregated by individual, and for each individual case, an anonymous unique identifier shall be provided.

- 3. The department shall provide its findings and recommendations to the Chairs of the House Appropriations, House Courts of Justice, Senate Finance and Appropriations, and Senate Judiciary Committees no later than October 15, 2020.
- P. Out of this appropriation, \$500,000 the first year from the general fund is provided for the Department of Criminal Justice Services to award grants to localities for training related to enforcement of the removal of firearms based on substantial risk protective orders.
- Q. Out of this appropriation, \$250,000 the first year and \$250,000 the second year from the general fund shall be provided for the Department of Criminal Justice Services to contract with Ayuda to provide immigrants legal, social, and language services for low-income victims of crime, including victims of domestic violence, sexual assault, human trafficking and child abuse, abandonment, and neglect. The services provided shall include case management, emergency client assistance, and mental health services in the preferred language of clients.
- R. Out of this appropriation, \$150,000 the first year from the general fund is provided for community assessments for youth and gang violence prevention initiatives in Hampton, Newport News, Norfolk, Richmond, Roanoke, and Petersburg.
- S.1. Included within the appropriation for this item is \$6,402,200 in the first year from the general fund for the Department to make one-time grants to law enforcement agencies located in the Commonwealth employing law enforcement officers with primary law enforcement duties, including but not limited to state agencies, local agencies, and colleges and universities, for the purpose of purchasing, operating, and maintaining body-worn camera systems. Qualified uses for grant funds shall include one-time costs associated with such body-worn camera systems, to include equipment, data storage, and technology costs, and other one-time costs associated with the purchase, operation, and maintenance of body-worn camera systems, as determined to be eligible by the Department.
- 2. The funding in this paragraph also includes \$56,895 in the first year and \$113,790 in the second year from the general fund for a coordinator position to manage the Body Worn Camera Grant.
- 3. Any distributions made to a local law enforcement agency under this paragraph shall require a 50 percent match from local fund sources.
- 4. The Department shall report on the distributions made under the Grant to the Chairs of the House Appropriations and the Senate Finance and Appropriations Committees by September 30, 2021. The report shall include information on distributions made by agency, description and amount of equipment purchased per agency, and any balances remaining from this funding.
- T. Included in the appropriation for this item is \$250,000 the second year from the general fund as a one-time appropriation for the Big H.O.M.I.E.S. program.

85	Chairman Scott called the worksession to order and turned the meeting over to VDOT Salem
86	Residency Administrator Todd Daniel and Assistant Administrator J. P. Morris for an overview of the Fiscal
87	year 2022-2027 Secondary Six-Year Plan (SSYP).
88	Mr. Daniel noted this process had to be skipped last year, and then gave a brief update on various
89	road projects:
90	• The bridge project over Goose Creek on Route 122 and a safety project on Route 460 have
91	been completed.
92	• A superstructure replacement on Dickerson Mill Road which will remove the weight
93	restrictions off the bridge once completed in early fall.
94	• A bridge replacement of Otter River on Route 122 north which should be completed in June
95	2022.
96	• A bridge replacement on Everett Road over the railroad which should be completed in spring
97	of 2022.
98	• The Route 460 "S" curves project is on schedule and will wrap up in the summer of 2022.
99	<ul> <li>Some other safety projects on Route 460 (shoulder paving, etc.)</li> </ul>
100	• The Route 644 bridge replacement project (also over Otter River) is behind schedule, but
101	should finish this spring.
102	• The overlays schedule (paving on Route 122 in Big Island, some slurry seal on some residential
103	streets in Forest, et cetera) which will continue throughout the summer.
104	Mr. Daniel then moved on to the SSYP, giving an overview of the process and the projects on the

the priority list, he will make those revisions and bring it back to the Board at a later meeting for adoption. He also noted that candidates for inclusion in the SSYP are typically unpaved roads that are already in the state system. He touched on the funding formula used to allocate funding, stating that projects which are finished under budget have their leftover funding funneled back into the plan for a future project; Bedford does not lose the funding. After his overview, Mr. Daniel answered clarifying questions from the Board.

Supervisor Davis said Camp Jaycee Road is having a problem with flooding and also needs shoulder work. Mr. Daniel said some minor improvements have been made to the culverts over the years, but currently, they do not have a reasonable economic solution for these issues as the elevation of the pavement is the problem. Mr. Daniel said there is currently nothing in place regarding the road's shoulders, but it's something they could work on. He said it would be some fairly involved road construction to add shoulders in that area; funding would be an issue. Also, because Camp Jaycee is not an unpaved road, the funding set aside specifically for unpaved roads could not be applied; this leaves only the "TeleFee" funds (approximately \$170,000 per year). Mr. Daniel said it would take approximately ten years to save up enough funding for the drainage and shoulder work for Camp Jaycee. He said he would, however, still continue to monitor the shoulder and drainage needs.

Supervisor Davis stated that the crossover safety project taking place at the intersection of Camp Jaycee Road and Route 460 is not popular with the residents on Camp Jaycee. He said that he wished the funding being used for the crossover could be used instead for the drainage and shoulder issues.

Mr. Daniel then turned the meeting over to Mr. Morris for a review of the proposed projects on the SSYP. After discussing their options on projects that could be added or repositioned with the Board, the Board reached a consensus to add Angel Place (first), Von Roy Road (second), and Moorman Road (third).

Mr. Daniel then distributed a concept drawing of the crossover project at Camp Jaycee Road, explaining that it was accepted as a SmartScale project after being submitted by the County in 2018. Supervisor Davis said he has received a lot of comments by the residents on Camp Jaycee explaining their reasons for opposing the project. Mr. Daniel said he has spoken to a few of those same citizens and reviewed the history of the project, noting that the project was approved due to the need for safety improvements (based on several years of accident data on Route 460 at this particular intersection).

Supervisor Davis stated people need to have some common sense when driving through the area.

Mr. Daniel noted that while the County can remove projects from the SSYP, removing a SmartScale project is much more difficult. Bedford can request the project be removed, but there is no guarantee the State will agree to remove it and the County *might* be responsible for reimbursing any funds that have already been expended on the project if it is cancelled. At this point, only \$16,452 has been spent on this particular project. There followed a discussion between Mr. Daniel and the Board regarding this issue, with the Board directing staff to schedule a meeting specifically to hear from the public regarding this project.

There being no further discussion, the Board recessed for a supper break at 6:31 pm.

269	a question from Supervisor Sharp, she confirmed this does not extend the end date and saves approximately		
270	\$21,000 per year.		
271	Supervisor Johnson made a motion to approve Resolution #R 051021-04.		
272	WHEREAS, the County of Bedford, Virginia (the "County"), entered into an Equipment		
273	Lease/Purchase Agreement dated as of April 1, 2012 (the "Original Lease Agreement"), with Capital One		
274	Bank, N.A. under which the County financed the costs of certain energy conservation improvements,		
275	including improvements to certain public school facilities (collectively, the "Improvements"); and		
276	WHEREAS, Capital One Public Funding, LLC has submitted a proposal (the "Proposal") to		
277	refinance the remaining payments under the Original Lease Agreement through either an amendment to the		
278	Original Lease Agreement or a new Equipment Lease/Purchase Agreement (collectively, the "Lease		
279	Agreement") with the County; and		
280	WHEREAS, the Board of Supervisors of the County of Bedford, Virginia (the "Board"), has		
281	determined that it is advisable to refinance the cost of the Improvements by entering into the Lease		
282	Agreement.		
283	Now, THEREFORE, BE IT RESOLVED, by the Bedford County Board of Supervisors:		
284	1. Acceptance of Proposal; Authorization and Execution of Documents. The County		

Administrator, or such officer as he may designate, is authorized and directed to accept the Proposal

presented to this meeting. The Board hereby determines that the acceptance of the Proposal and the refinancing of the remaining costs under the Original Lease Agreement will benefit the inhabitants of the County by promoting their safety, health, welfare, convenience or prosperity. 

#### SUMMARY

An RFP was issued on May 25, 2021. Six companies submitted proposals by the submission deadline of 5:00 pm on Tuesday, June 29<sup>th</sup>. The County Administrator, Deputy County Administrator, and Director of Human Resources thoroughly reviewed each proposal against the criteria that was defined in the Evaluation Criteria section of the RFP. Three companies were chosen to move forward into a formal interview process. These interviews were conducted by the County Administrator, Deputy County Administrator, Assistant Finance Director, Director of Human Resources, and Human Resources Generalist on July 22 and 23, using a webinar format. After taking into consideration each firms skills, experience, and ability to complete the work in the described time frame, staff concluded that Evergreen Solutions, LLC was the most responsive and advantageous to meet the needs of the County. Staff completed and received positive reference checks the week of July 26<sup>th</sup>.

Evergreen Solutions, LLC commits to having the project completed by January 31, 2022, to allow for recommendations to be considered in the FY23 budget.

#### FISCAL IMPACT

Evergreen Solutions agrees to complete all work related to the compensation and classification study for \$46,000, which includes professional fees, travel, and expenses. The FY22 budget includes \$50,000 in the Human Resources Operating Budget to cover these costs. Staff recommends any remaining balance be paid by budget contingency.

Any implementation costs will be presented to the Board for consideration at a later date and handled <sup>9a</sup> separately as part of future operating budget(s).

### PRIOR ACTIONS

2015: Bedford County completed a similar study.

On May 24, 2021, the Board of Supervisors authorized staff to issue an RFP to solicit firms for the purpose of evaluating and making recommendations to update and improve the County's classification and compensation practices and procedures.






