A Message from the County Administrator

I've received the opportunity to speak about the County at a few meetings over the past month. During two of them with community members and business leaders, I took the opportunity to tout our economic development successes and explain our approach. There is a common misconception that a community is only successful if we are announcing 100+ employee industry relocations. Of course, we would like to get those in Bedford County and our staff, coupled with the Lynchburg Regional Alliance, is consistently out there selling our community. However, I would rather experience success by assisting our existing industries and businesses. After all, they have already chosen to be part of this community. They pay taxes, donate to charities, fund youth activities, employ residents, volunteer, and make our community stronger.



When our industries are ready to add jobs or another line of production, we want to be present and assist if needed. That doesn't happen unless relationships already exist and they trust that our staff and EDA are here to help. Thanks to their good work, over the past 12 months, we've had six announcements of expansions totaling 108 jobs in six different companies. Additionally, the staff and EDA are currently working on a couple more that will hopefully be announced within the upcoming months. We are marketing to the world about our first class industrial parks and community. The almost complete shell building in New London will add to the lure of Bedford County and it will get filled by the right business at the right time. However, in the meantime, we will continue to pound the pavement with the goal of making our existing businesses and industries even stronger.

In another speaking engagement, I had the honor to recognize employees who have achieved milestones of service to the community. We honored 66 employees who achieved five year anniversaries all the way up to one who has been working for Bedford County for 40 years. I was amazed at the family like feeling of the ceremony. Each department director and Constitutional Officer presented the service awards to their staff and blessed the individual honoree and those listening with personal anecdotes. This created an awesome atmosphere of emotion and gratitude.

I can't begin to recognize all the time, energy, sweat, smiles, and tears that our employees give to this organization and community; but I really value the effort they bring every day on behalf of the taxpayers and how they support each other. I was so happy to play a role in the service award ceremony and look forward to the next opportunity to recognize our deserving employees.

Upcoming Public Hearings

Notice is hereby given that the Bedford County Board of Supervisors will conduct a public hearing on Monday, February 24, 2020 at 7:00 pm regarding the following rezoning, special use permit, text amendment, and proffer amendment applications:

- **Rezoning Application #RZ050002** is a request by Seven Hills Enterprises, LLC (George V. Rowe) to modify Proffers #3 and #4 that were accepted in association with the Bellevue Terrace Rezoning approved on February 14, 2005. Proffer #3 currently states “No home shall be permitted to be constructed on any lot that contains less than 3,000 square-feet of finished living space for a two story house, or 2,500 feet for a one story house”. The applicant is proposing to amend Proffer #3 by adding the following sentence “For Lots 114-11-1 through 7 and lot 114-11-11 the minimum home square footage shall be 2000 square feet for a two-story home and 1600 square feet for a one-story home”. Proffer #4 currently states “Architectural standards for all homes and accessory structures are to be primarily brick or stone, with Hardi Plank or similar cement fiber siding product covering less than half of the building exterior. Architectural grade shingles or better roof material must be used. There shall be no exposed concrete CMU foundations. Homes shall be of a generally traditional appearance, in keeping with other finer homes in the area”. The applicant is proposing to amend Proffer #4 by adding the following sentence “For Lots 114-11-1 through 7 and lot 114-11-11 vinyl siding is allowed as an exterior finish”. Since the Planning Commission public hearing held on January 21, 2020, the applicant has modified his proposed statement to amend Proffer #3 by adding "For lots 114-11-1 through 7, the minimum home square footage shall be 2000 square feet for a two-story home and 1600 square feet for a one-story home." Additionally, the applicant has modified his proposed statement to amend Proffer #4 by adding "For lots 114-11-1 through 7, vinyl siding is allowed as an exterior finish material in lieu of brick, stone or Hardie." The proposed changes now excludes Lot 114-11-11, and would apply to seven (7) of the eight (8) remaining lots owned by Seven Hills Enterprises, LLC. These lots are located in the Agricultural Village Center (AV) zoning district. Tax Map Numbers: 114-A-82, 114-11-1, 114-11-2, 114-11-3, 114-11-4, 114-11-5, 114-11-6, 114-11-7, 114-11-8, 114-11-9, 114-11-10, 114-11-11 and 114-11-12.
- **Rezoning Application #RZ19-0001** is a request by Gumtree, LLC to rezone Tax Map Number 100-A-12A by removing the Historic Overlay (HO) district from the property. The future land use designation for the subject property is “Agricultural/Natural Resource Stewardship” in the 2030 Bedford County Comprehensive Plan Future Land Use Map. The purpose of the Historic Overlay district is to recognize, preserve, and encourage the continued appropriate development of historic resources in designated areas by establishing standards for development and allowable uses that will insure such development. While much of the area in these districts may remain virtually unchanged other sections may need to change to serve the best interest of the area and its environs and the surrounding property owners. Typical uses within this district include restoration and reconstruction of historic structures, related residential, educational, administrative, maintenance, public assembly, festival activities, and limited supporting commercial activities. The applicant is proposing to develop the subject parcel with a driving range (“Commercial Outdoor Sports and Recreation” use). The property is located on Gumtree Road, adjacent to the Colonial Hills Golf Course (1926 Gumtree Road) to the north and 1770 Gumtree Road to the south and is 8 acres in size, according to Bedford County Real Estate information. The subject property is currently owned by Gumtree, LLC and is presently zoned Planned Commercial Development (PCD) district with Historic Overlay (HO) district. Voluntary proffers have not been offered by the applicant.

Notice is hereby given that the Bedford County Board of Supervisors will conduct a public hearing on Monday, February 24, 2020 at 7:00 pm regarding the following rezoning, special use permit, text amendment, and proffer amendment applications (*continued from previous page*):

- **Special Use Permit Application #SU19-0002** is a request by Gumtree, LLC to allow a “Commercial Outdoor Sports and Recreation” use on an 8-acre parcel, zoned Planned Commercial Development (PCD) district with Historic Overlay (HO) district, for a golf driving range. The property is located on Gumtree Road, adjacent to the Colonial Hills Golf Course (1926 Gumtree Road) and 1770 Gumtree Road. Tax Map #100-A-12A.
- **Special Use Permit Application #SU160007** is an amendment request by Thomas Road Baptist Church to expand an existing “Camp” use by more than 50 percent in an AP (Agricultural Rural Preserve) zoning district in accordance with Section 30-24-1(F) of the Bedford County Zoning Ordinance. Improvements to the property associated with this amendment request include the addition of one (1) 2,040 square foot staff cabin, ten (10) 2,040 square foot camper cabins, and two (2) 4,080 square foot family cabins. The property is located at 7794 Sheep Creek Road. Tax Map Number: 53-A-1G.
- **Zoning Text Amendment.** This amendment removes §30-82-11(b)(3) regarding rear setbacks and re-establishes the setback for multifamily structures in the AV,R-3, R-4, and C-1 zoning districts. For new multifamily structures at Smith Mountain Lake, the rear setback will be measured from the recognized full pond level. Additionally, the principal structure shall be located a minimum of ten (10) feet from the eight-hundred (800) foot contour. Walkways and steps are exempt from rear yard requirements.

The Board of Supervisors public hearing will be held in the Bedford County Administration Building Boardroom, 122 E. Main St., Bedford, VA. Copies of the applications are available for public inspection at the offices of the County Administrator and at the Department of Community Development located in the Bedford County Administration Building, 122 E. Main St., Bedford, VA., telephone 540-586-7616. Persons affected may appear and will be provided opportunity to present their views.

The census counts every person living in the U.S. once, only once, and in the right place.

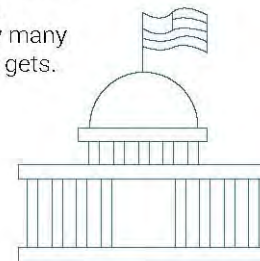


It's in the Constitution.

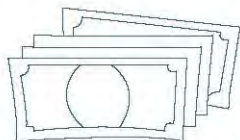
The U.S. Constitution requires a census every 10 years. The census covers the entire country and everyone living here. The first census was in 1790.

It's about fair representation.

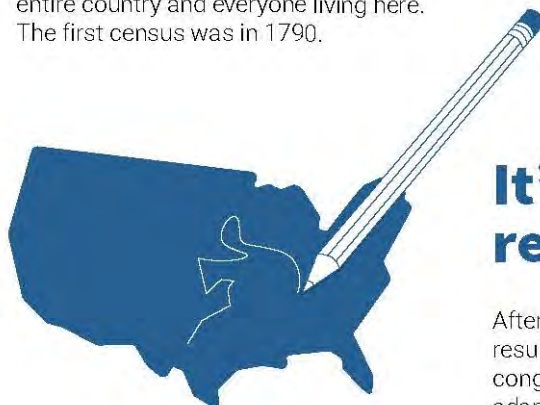
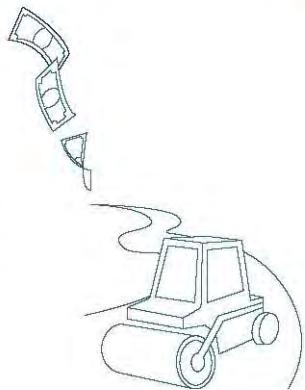
Every 10 years, the results of the census are used to reapportion the House of Representatives, determining how many seats each state gets.

Census data determine how more than \$675 billion are spent, supporting your state, county and community's vital programs.

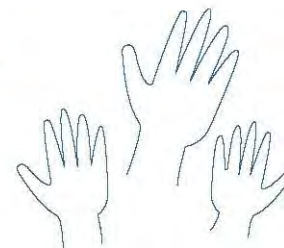


It's about redistricting.

Completing the census is required: it's a way to participate in our democracy and say "I COUNT!"



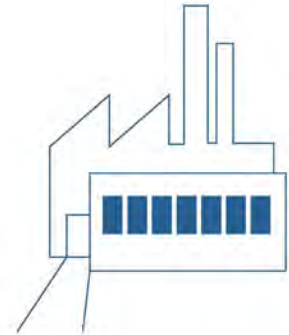

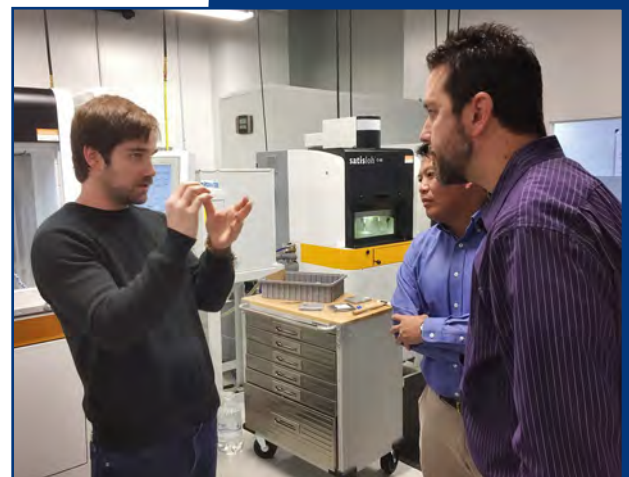
Custom Truck One Source Doubles Production in Bedford County

BCo.FR Big Island Medic 14-2 Quarters Remodel

Remodeling and renovations in the Big Island Emergency Crew facility on Route 501 has recently been completed. This facility houses Bedford County Fire & Rescue Medic 14-2 career staff consisting of six Firefighter/Medics on a 24/7 basis with two on duty per shift. In the continued partnership with the Big Island community and as staffing needs evolve, the traditional the volunteer Fire and Rescue facilities often are lacking in accommodations for 24/7 Career Staffing.

Fortunately, in Big Island the physical plant was such that it allowed a remodel establishing two individual bunk rooms, an updated bathroom, and previously non-existent shower facilities, while taking advantage of the existing kitchen and dining area. Enhancing what had been a less-than-desirable stairwell configuration and allowing the responders to access the medic units for emergency response will provide increased safety and efficiency in timeliness of response. This upgrade in no way impacts the facilities currently used by the volunteer Cadre and maintains a separate but equal distribution of resources.

The CIP line item for this type of project is truly the lifeblood of these projects. This upgrade was accomplished within the expected timeframe and slightly under the \$25,000 cost estimate, with Big Island Emergency Crew serving as the general contractor and Deputy Chief Janet Blankenship managing the needs and design tasks.

The next major initiative is with the Stewartsville Rescue Squad and honoring our agreement to establish permanent quarters for the career staff at Medic 14-13 assignment, as the six Firefighter/Medics continue to reside in a temporary construction trailer located behind the rescue squad building.

New IRS Form W-4 for 2020

The IRS has announced significant changes to the IRS Form W-4, Employee's Withholding Certificate, for 2020. The new form and revised withholding calculations could affect your tax withholding and year-end refund or tax due amounts when you file your annual income tax return.

The 2020 Form W-4 is designed to be both easier and more accurate, permitting easy adjustments for anticipated tax credits, other income and deductions.

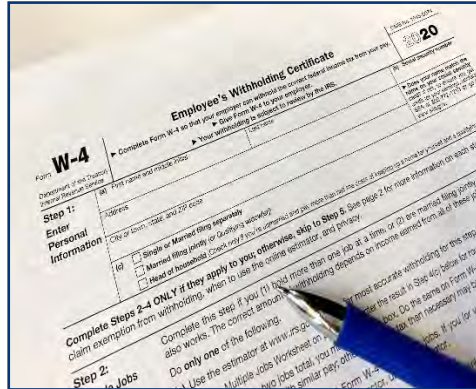
If you would like to adjust your withholding to account for these factors, you will now be able to simply enter your full-year estimated amounts on the Form W-4.

The IRS has provided an online "Withholding Estimator" at <http://www.irs.gov/w4app> to determine how to complete the 2020 Form W-4 so that you don't have too much or too little withheld during the year.

Form W-4 Highlights

- There are three options for employees with multiple jobs or two-earner families:
 - ✓ Simplified worksheet in the W-4 instructions
 - ✓ Enhanced IRS online Withholding Estimator
 - ✓ New checkbox to automatically adjust for multiple jobs or two-earner families
- New filing status — Head of Household
- New adjustment entries:
 - ✓ Full-year child and dependent tax credits
 - ✓ Full-year other income; and,
 - ✓ Full-year deductions

GOOD NEWS:

Mountain Cross!....what is it?

The Mountain part refers to many of the same aspects that you might encounter in a mountain bike race. There are single track with rocks, roots and log overs but will only make up approximately 50% of the course. The Cross is similar to a cyclocross race mixing in grass paths, short sections of pavement or gravel road and similar lap distance. The racers will also be required to dismount to clear barriers on the



course. The race course is 1.5-2 miles per lap and will be changed for each race. When combined, these two cycling disciplines mesh nicely to make up what is called Mountain Cross. The races are short, intense and loads of fun!

The Equalizer Format is used to score these races. This is similar to the golf handicapping system. In golf, players of different abilities can play fun and competitive rounds against one another. Since their handicaps equalize their scores the golfer that plays his or her best, regardless of their level of experience, can win! The equalizer format allows riders/racers of all ages and ability levels to race for the overall race win.



A bonus of the format is that fast experienced racers who normally only have to worry about finishing ahead of the other top racers now have to push themselves to compete with beginners! The winner is the racer who does the most laps. Series winners will be the racers completing the most laps combined from all the races. In the event of a tie the racer with the most laps in the least amount of time wins. (Example: 20 laps in 1:55:05 beats 20 laps in 1:59:00)

Duolingo gives you the option to either start with the basics or take a placement test to see what you already know. The lessons are divided into categories such as color, clothing, food, time, and basic questions and phrases. To get the full experience of Duolingo, I recommend using a headset with a microphone. The service helps with reading, writing, speaking, and listening to the language. If you do not have a headset, the program allows you to skip that portion of the lesson and instead concentrates on reading and writing. Duolingo is so effective that studies have shown that 34 hours of use is equal to 1 university semester! What makes this language learning experience unique is that you can connect with other users and form special groups to motivate each other. If you'd rather go solo, you can set your own daily goals. Duolingo also awards achievement badges and crowns to increase your user level, as well as the virtual currency, Lingots, which can be redeemed at the Duolingo shop for skills or items. The site also sends emails to remind you to practice and login if you miss a few days.



Duolingo also offers fantasy languages for the pop culture fans in our midst. If you want to learn High Valyrian from the hit series Game of Thrones, or Klingon from Star Trek, Duolingo can help. So kick those winter blues to the curb and join the over 300 million Duolingo users worldwide in learning something new about your world.

Meetings took place with Delegate Kathy Byron, Delegate Terry Austin, and Senator Steve Newman. There was conversation about current projects and bills, and the opportunity to ask questions. Participants toured the Capitol and sat in briefly during General Assembly sessions in both the House and the Senate, and received special recognition from the floor.
